Registration - Weigh-Ins: Coaches to email/call in weights

And NO WEIGH-INS THE DAY OF THE TOURNAMENT. Random weight checks will be conducted.

Weigh-Ins: - All challenges must be completed before the end of Round 1 and will require a non-refundable \$25.00 fee.

Entry Fee: Elite - \$25 Novice - \$20

Awards: "Elite" Division Champions will receive a championship belt! Trophies given for 2nd, 3rd and 4th place finishers.
"Novice" Division Champions will receive a trophy. Medals given for 2nd, 3rd, and 4th place finishers.

Rules: Modified Scholastic Rules will be used for all divisions. All neutral starts

Divisions 1, 2: Two (2) 1 minute periods

Divisions 3 & 4: Three (3) 1 minute periods
