There will be NO coolers allowed in the gym areas. Tobacco use is prohibited in and on all school owned grounds.

Coaches Bands: They will be handed out ONLY during the Friday night and Saturday morning weigh-ins. In order to obtain a coach's band, you must report to the weight room at WRHS OR at satellite sites TBD weigh in (Friday Only) and present the following items:

1. 2017-2018 Coaches Card
2. Bronze level certification card
3. Photo identification

Only banded coaches and wrestlers competing will be allowed mat side, 2 coaches per corner. This will be strictly enforced so please let your parents know ahead of time. All video and photography needs to be done from the stands.

Awards: Medals will be awarded to top 4 placers.

Weigh-in: Friday Night 6:00 PM - 8:00 PM Saturday 6:00 AM - 7:00 AM at WRHS. Wrestlers must weigh-in wearing competition singlet. **No Parents or coaches will be allowed in the weigh-in area.** There is NO weight allowance.

Satellite Weigh-In Location is TBD, watch for an email from Rich and post on the talk forums.

Entry Fee:

8U-14U will be paid at the Sub-District site.

High School Division: \$25.00 Per Wrestler (Non-Refundable) Make checks payable to Topeka Blue Thunder OR pay through trackwrestling.com

Registration:

We will be utilizing www.trackwrestling.com. Each club will be responsible for inputting their wrestlers into track wrestling. Your club contact will utilize the Trackwrestling Pre-registration like a normal tournament. ONLY the club contact can enter information for their clubs. The deadline for entering your wrestler's information into the track wrestling site is March 17th, 2018 @ 06:00 AM. **Once you have**

entered a wrestler into the system there will be NO REFUND even if you scratch them at the seeding meeting. All payments must be paid online OR brought to the seeding meeting on March 17th, 2018 at WRHS or your wrestler will not be entered into the tournament.

Seeding Meeting: Once the HS division seeding starts, there will be no changes, or additions allowed except in the case of clerical errors by the tournament director. The District 3 seeding meeting will be held at WRHS on March 17th, 2018 at 7:00 AM. **Reminder that if you do not show up for the seeding meeting do not complain about the seeding your wrestler receives.**

Rules:

All wrestlers must have a current USAW card and be entered as part of a USAW sanctioned KS club (no independent entries). All wrestlers will follow all rules for USAW Kansas Kids Sanctioned Tournaments. Club directors will be held responsible for the actions of all their wrestlers, coaches and parents. Fingernails will be checked at weigh-in. No wrestler will be permitted to wrestle with ANY type of communicable skin disease. Each wrestler with signs of communicable disease should have a NFHS Medical Release Form at the time of weigh in, which must be filled out by a physician and dated within the last six days along with a note from a doctor's note pad signed. A copy of the NFHS release form must also be with the wrestler at all times at the tournament for review upon request.

Placement Information: Clubs with a wrestler that places in the top 4 and can't continue to the State tournament need to notify the District and Tournament director immediately after the placement. 5th and 6th places will be wrestled to determine alternates. Club Directors will submit one club check for all state qualifiers entry fees before leaving the tournament. Checks payable to USAW-KS District 3. Entry fee is \$25 per wrestler.
