**Walk-In Registration:** Registration will be open from 6:00 - 9:00 PM on Friday September 6th and between 7:00 - 8:00 AM on Saturday September 7th. Print/Fill out the registration form, complete and provide cash or check payable to: "Beat the Streets"

**Coach Registration:** Coaching bracelets will be available on site for \$20.

**WEIGH-INS:**

Weigh-ins will be Friday night, September 6th from 6:00 - 9:00 PM and Saturday morning, September 7th from 7:00 - 8:00 AM at PCTA. Check in at registration upon arrival to be designated to your scale. Skin checks will be performed and the appropriate staff have the final call; a wrestler must have an official doctor's note to wrestle if anything is called into question. All wrestlers must weigh-in with undergarment, shorts, or singlet on.

**ONLINE REGISTRANT WEIGHT CHANGES:**

You must wrestle at the weight you registered for. You have up until 10:00 PM on Thursday, September 5th to email the tournament director and change your registered weight with NO penalty. No weight changes will be made after September 5th. If you do not make your registered weight at the time of weigh-ins, the penalty to change a weight class is an additional \$10. If not, you will not be able to wrestle, and your entry fee will not be refunded.

**TOURNAMENT RULES:**

- Running on 9 mats
- Medals for Top 3 Place Finishers
- Certified HS officials and trainers
- Double elimination format
- Singlets/Compression gear required
- 1-minute sudden death followed by :30 second ride out
- This is a NON-SEEDED Tournament (random draw), PLEASE LIST YOUR CLUB TO BE SEPARATED FROM TEAMMATES
- Qualified wrestlers may compete in a different weight class at the Super 32 in October
- All HS matches will be 2-2-2
- All Girls matched will be 2-0:30-2
- All youth matches will be 1:30-1:30-1:30
- NFHS rules with college out-of-bounds
- HS wrestlers must be enrolled in 9-12th grade

**CANCELATION/REFUND:**

Pre-registration entries may be refunded prior to the time at which we reach our entry limit or cut off registration. If you realize you must cancel or require a refund you must email the tournament director requesting to do so. No refunds will be given after Thursday 9/5/2019. Refunds will be given to the merchant, in the amount which was given in the online fee.

**ADMISSION/SPECTATORS:**

Admission is \$10 for adults and \$5 for school age children, children under 5 are free. Coaches may buy \$20, coaches band which will allow you to be on the mat to coach. Security will be on site. Doors will open at 7:00 am Saturday, September 7th. Bleachers are provided for seating, and there will be floor space available for folding chairs. I further understand that Wrestling involves a particularly high risk of knee, head, and neck injury. In addition, I understand that participation in Wrestling involves activities incidental thereto, including, but not limited to, travel to and from the site for the activity, participation at sites that may be remote from available medical assistance, and the possible reckless conduct of other participants. I am voluntarily allowing my child to participate in this activity with knowledge of the danger involved and hereby agree to accept any and all inherent risks of property damage, my child's personal injury, or my child's death.
