**WHEN:** Saturday, March 28, 2020

**EXPERIENCE LEVELS:** This tournament is intended for Novice/Intermediate Level competition. No "Advanced" wrestlers please.

**TIME:** Doors open at 8:00am

**Session 1:** 9:00am 4 & Under, 8 & Under, 12 & Under. Wrestlers must check in by 8:30am

**Session 2:** 11:30am 6 & Under, 10 & Under. Wrestlers must check in by 11:00am

**REGISTRATION:** On TrackWrestling.com with Honor Weight System- enter exact weights.

**AGE Groups:** The age of the wrestlers will be determined as of January 1, 2020.

Ages: 4 & Under; 6 & Under; 8 & Under; 10 & Under; 12 & Under

**LOCATION:** University Middle School 1717 65<sup>th</sup> Avenue Greeley, CO 80634

**PARKING:** Parking may be limited at the Middle School with other events in the area. Additional parking at University High School 6525 W. 18<sup>th</sup> Street, CO 80634

**ENTRY FEE:** \$20 per wrestler. Wrestlers may double bracket, but must pay both \$20 entry fees

**ADMISSIONS:** \$8 Coaches, \$5 Adults, \$3 Students (K-12)

**BRACKETING:** 2-6 Man Round Robins. Brackets will be released on Trackwrestling.com 6:00pm Friday, March 27<sup>th</sup>.

**RULES:** Collegiate rules apply except for the following:

1. Ages 4 through 10 years will wrestle three 1 minute periods.
2. Ages 12 will wrestle three 1 ½ minute periods.
3. Ties will be broken with a one minute overtime period with both wrestlers on their feet. The first take down wins. If the tie remains then the first points scored in regulation wins.

**AWARDS:** 1<sup>st</sup> through 3<sup>rd</sup> place medals.

**WAIVERS:** Signed waivers will be collected at check-in. Wrestlers will not be allowed to participate without it.

**\*\*Wrestlers will wrestle a minimum of two matches. \*\***

# Release and Waiver of Liability and Indemnity Agreement

(Read Carefully Before Signing)

In consideration of being permitted to participate in any way in the University Junior Bulldog Wrestling Tournament indicated below and/or being permitted to enter for any purpose any restricted area (here in defined as any area where in admittance to the general public is prohibited), the parent(s) and/or legal guardian(s) of the minor participant named below agree:

1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the University Junior Bulldog Wrestling Tournament, he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe, the participant should immediately advise the officials of such condition and refuse to participate. I understand and agree that, if at any time, I feel anything to be UNSAFE; I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.

2. I/WE fully understand and acknowledge that:

(a) There are risks and dangers associated with participation in wrestling events, and activities, which could result in bodily injury partial and/or total disability, paralysis, and death.

(b) The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe.

(c) These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including, but not limited to, the Releases named below.

(d) There may be other risks not known or are not reasonably foreseeable at his time.

3. I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence of the Releases named below.

4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the University Schools facilities used by the participant, including its owners, managers, promoters, lessees of premises used to conduct University Junior Bulldog Wrestling Tournament, premises and event inspectors, underwriters, consultants and others who give recommendations, directions, or instructions, to engage in risk evaluation or loss control activities regarding University Schools facility or events held at such facility and each of them, their directors, officers, agents, employees, all for the purposes herein referred to as "Releasee"...FROM ALL LIABILITY TO THE UNDERSIGNED, my/our personal representatives, assigns, executors, heirs and next of kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES AND ANY CLAIMS OR DEMANDS THEREFORE ON ACCOUNT OF ANY INJURY, INCLUDING BUT NOT LIMITED TO THE DEATH OF THE PARTICIPANT OR DAMAGE TO PROPERTY, ARISING OUT OF OR RELATING TO THE EVENT(S) CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEE OR OTHERWISE.

5. I/WE HEREBY acknowledge that THE ACTIVITIES OF THE EVENT (S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

6. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.

7. On behalf of the participant and individually, the undersigned partner(s) and/or legal guardian(s) for the minor participant execute this Waiver and Release. If, despite this release, the participant makes a claim against any of the Releases, the parent(s) and/or legal guardian(s) will reimburse the Releasee for any money, which they have paid to the participant, or on his behalf, and hold them harmless.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
