Other Tournament Information

Registration for the tournament will be done on Trackwrestling.com. All teams & individual entries should have all competitors entered by Monday, December 21 at 6 pm. This information is necessary to ensure proper seeding and counts per weight class. Last minute changes can be made to rosters at registration on December 28.

All teams and individual wrestlers must check-in at the registration table and declare weight classes for each wrestler. **FINAL WEIGHT DECLARATION MUST BE MADE BY 4:00 PM ON DECEMBER 28.** Coach & competitor passes will be issued at check-in.

NCAA rules will be used for all matches and team scoring.

- 7 minute match length for all matches
- Riding time in effect for all matches
- Overtime will follow most current NCAA rules; video review at Official's discretion

Bracket sheets for coaches will be distributed at the Head Table.

All mats will have 3 chairs for each competitor reserved for 2 coaches plus one medical attendant for each match. All others must stay in areas reserved for them.

Ear guards are required for each match. International cut singlets are acceptable.

All competitors will receive passes. Below is the coach/staff pass policy which is based on the number of competitors and will be strictly adhered to. Additional passes can be purchased at onsite registration for \$35 per pass. Passes will be distributed at registration on December 28. Contestants must have their pass for entry into the weigh in area as well as admission to the arena.
