Spectators age twelve (12) and above \$5.00.

ENTRY FORMS:

We will be utilizing www.trackwrestling.com. Each club will be responsible for inputting their wrestlers into this system. The deadline for entering your wrestler's information into the www.trackwrestling.com site is **March 2nd, 2022 at 5:00pm**, one hour before seeding meeting. **Once you have entered a wrestler into the system, there will be NO REFUND even if you scratch them at the seeding meeting.** When registering your wrestlers, REMEMBER 6 & under and novice records cannot be used. Please rate your wrestlers with the separation criteria provided in trackwrestling.

Coaches must have a Bronze Card AND USA Coaches Card.

SEEDING MEETING

Zoom meeting invite will be sent out to club emails the week of the seeding meeting. One Zoom invite per club. **Reminder that if you do not show up for the seeding meeting do not complain about the seeding your wrestlers receive.**

RULES:

All wrestlers must have a current USAW card and be entered as part of a USAW sanctioned Kansas club (no independent entries). All wrestlers will follow all rules for USAW Kansas Kids Sanctioned Tournaments. Club directors will be held responsible for the actions of all their wrestlers, coaches, and parents. Skin and fingernails will be checked at weigh-in. No wrestler will be permitted to wrestle with ANY type of communicable skin disease.

COVID 19 GUIDELINES:

Please be aware that some restrictions may come in to play depending on county mandates. This could include masks, limited entrance, and session time/date changes.

STATE TOURNAMENT

All kids must declare intent to move on to the state tournament in Topeka. Payment will be made in the form of one single check per club to cover all kids from that club who qualify for state to made out to Hays Wrestling Club.
