5:30 Finals begin (Time is approximate. Finals begin 1 hour after the completion of previous rounds.)

BADGES: Please send a list of wrestlers (with year in school), coaches and statisticians last names to carmen.lira@medford.k12.or.us by Monday, February 14 at noon so that a badges can be made Include any potential district wrestlers on this list. Badges are required for entry to the event.

**ARRIVAL:** Teams are not to arrive at South Medford High School before 7:30 a.m. on Saturday, February 19.

**LOCKER ROOMS:** Locker room space will be available for changing only. It is strongly recommended that each team have its own security system for valuables and bring towels if wrestlers wish to shower. Sheldon, South Eugene and North Medford will use the men's PE locker room. North Medford, Grants Pass and Roseburg will use the women's PE locker room.

**PARTICIPANTS:** Only competing wrestlers will be allowed on the competition mats. Wrestlers on deck need to remain in the warm-up/staging area until escorted to their mat.

A team coach must be present with wrestlers in the gym between sessions.

Six coaches and two statisticians from each school will be admitted to the District Tournament.

Team seating (stat girls, wrestlers, and coaches only) will be in the designated areas in the main gym, until the finals. The staging area will be in front of the Main bleachers. The warm-up area is in the Wrestling Room.

MAT SIDE: Only two coaches and one statistician per wrestler will be allowed at mat side on the main gym floor. This will be strictly enforced!

NO SPECTATORS are permitted at the District Tournament this year 2022. Everyone who enters the gym will need a District Tournament badge.

**CONCESSIONS:** Due to Covid protocol there will be <u>no concessions</u> available. Please advise your Coaches and Teams to bring food and drink to get them through their day. The Commons will be open and available for all to find a place to take a break from the gym, sit down, and eat.

**RESULTS/AWARDS:** Updated results can be obtained throughout the tournament on trackwrestling.com.

Wall brackets will be presented to the champion. In addition, medals will be presented to the top three wrestlers in each weight class and ribbons will be presented to 4<sup>th</sup> –6<sup>th</sup> place wrestlers.

All placers are to remain in uniform for the awards presentation. Awards will be presented between matches throughout the finals. No hats or headwear of any type is to be worn during presentation of the awards. Awards in each weight class will be presented by the head coach of the champion wrestler for that weight class.

Coach of the Year, as voted by the SWC coaches, will be acknowledged at the completion of the tournament.

**STATE QUALIFIERS:** Wrestlers who place 1<sup>st</sup> through 3<sup>rd</sup> in their weight division shall qualify for the State Tournament. The District Tournament Director will forward the complete records for each qualifier to the State Tournament Director. (Coaches are responsible for providing state seeding information to the District Tournament Director.)

4<sup>th</sup> place will be put into a wild card selection based off of OSAA qualification guidelines.

OSAA- Cut-off Date – The automatic qualifiers must be determined by 10pm on Saturday, February 19. Once the qualifiers are determined, the fourth-place finisher from each league will be "pooled" and a defined criterion applied to select three additional qualifiers.

In the event of injury or illness to a state qualifier, please contact the replacement wrestler's coach and the Tournament Director as soon as possible by phone. The State will be notified immediately.
