The Desert Storm Invitational will be using www.trackwrestling.com for bracketing and online viewing.

Tournament Format:

Varsity – Double elimination bracket tournament placing top six JV Day 1 – Scramble and round robin, for next day seeding. JV Day 2 – Bracket tournament; "A" bracket will place top four wrestlers.

Monday, December 13TH 2021 – All teams will receive an online link to enter their wrestlers information for the tournament through www.trackwrestling.com. The link will be sent to the head coach with a login and password. Coaches will have until Thursday at 11:00 pm MST to enter all wrestlers and make any changes needed.

Friday, December 17TH 2021 – Weigh-ins will be conducted by each coach at their home school on Friday morning. All weigh in forms need to be faxed or e-mailed to the Tournament Director by 10:00 am. Scales and Skin Checks will be available at 1:00 pm to those schools wanting or needing to weigh in at Dixie High. Coaches meeting will be held at 2:00 pm. Wrestling will start at 3:00 pm.

Saturday, December 18th 2021 – Weigh ins - 7:00 am Wrestling will start at 9:00 am. Wrestling will run straight through until completion. Awards will take place at the conclusion of the championship finals.

Awards: Varsity: Place top six per weight, with Team Champion and Team Runner up awards. JV: Place top four per weight class, with JV Team Champion award.

Coaches: - Lunch and dinner will be provided on Friday. A light breakfast and lunch will be provided on Saturday.

Weigh-Ins: Friday Dec. 17TH – Weigh-ins will be done at home school with weigh-in forms being e-mailed or faxed to Tournament Director by 10:00 am.

Saturday Dec. 18Th – Weigh-ins 7:00 am.
